He is a former commander of the Army of the Republic of Bosnia and Herzegovina in its militia, the Army of the Republic of Bosnia and Herzegovina (ARBiH). He was the highest-ranking soldier captured following the Dayton Agreement, and he was also one of the most wanted war criminals in the world. Personal life and education Stanković was born in the town of Stupno in Central Bosnia Canton, a section of Bosnia and Herzegovina that is in the Federation of Bosnia and Herzegovina. His family were Bosnian Serbs from the municipality of Bilić. He married for the first time in 1971. He received his primary and secondary education in Stupno. In 1989, he graduated from the Faculty of Economics, and in 1991 he was appointed head of the Accounting Department of the First Faculty of Economics in Sarajevo. Arrest and conviction In 1992, he graduated from the Faculty of Law in Sarajevo, and after graduation in 1992 he became a battalion commander in the Territorial Defence of Bosnia and Herzegovina. In 1993 he was the commander of the 5th company of the Banja Luka Territorial
